STIPULATION

IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned, as follows:


1. That Respondent, Robert E. Chandler Corporation, who obtained a compulsory pooling Order R-8047 dated September 25, 1985 from Respondent, New Mexico Oil Conservation Commission, as a result of market conditions, is unable to proceed with the drilling of the subject well in the NE/4SW/4 of Section 4, T23S, R38E, NMPM, Lea County, New Mexico, and therefore voluntarily agrees that the Commission shall enter an order making Order R-8047 void and of no effect.

2. That the appeal taken by the Petitioners of the Oil Conservation Commission Order R-8047 shall be dismissed.




