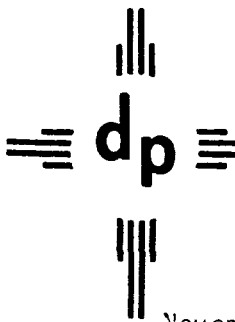

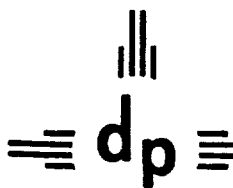
Although we would prefer to buy your interest, the 40% overriding royalty interest you proposed is not acceptable.
