Amoco Production Company hereby makes application for an order from the New Mexico Oil Conservation Division pooling all mineral interests in the Gavilan-Mancos Oil Pool underlying Section 2, T26N-R2W, Rio Arriba County, New Mexico, forming a standard 640-acre oil spacing and proration unit. This proration unit will be dedicated to the Bear Canyon Unit Well No. 4 to be located 790 feet FSL and 850 feet FWL (SW SW) Section 2, T26N-R2W.

Applicant further seeks: a 200 percent penalty to be assessed against all nonconsenting working interest owners as a charge for risk involved in the drilling of said well in addition to the actual costs of drilling and completing; and \$3,222.00 per month while drilling and \$401.00 per month while producing, to be fixed as reasonable overhead charges. Applicant also requests that Amoco Production Company be named as operator of said well.


We respectfully request this matter to be set for hearing on the October 26, 1988 docket.
