

EXAMINER STOGNER: Okay, at this time I'll call Case Number 10,855, which is the Application of Meridian Oil, Inc., to amend Division Order No. R-9921, San Juan County, New Mexico.

Call for appearances.

MR. KELLAHIN: Mr. Examiner, I'm Tom Kellahin of the Santa Fe law firm of Kellahin and Kellahin, appearing on behalf of Meridian Oil, Inc.

I do not have any witnesses in this case.

EXAMINER STOGNER: Okay. There appear to be no other appearances?

Mr. Kellahin?

MR. KELLAHIN: Mr. Examiner, what we'd like to recommend to you in this case is that you incorporate the record which would include the transcript and exhibits, the testimony of a couple of other cases, and that with that evidence, then, you would have a record upon which to enter an order for the three wells involved in Case 10,855.

And should you so desire, then, you will be making the consistent choice of an order for ten wells, all of which Meridian seeks downhole commingling approval of Pictured Cliffs and Fruitland Gas under an economic criteria that is consistent in all those cases.

1 What we're asking you, then, to do is for purposes of this hearing, that you would consolidate and 2 incorporate the transcripts in Case 10,721, 10,722, 10,723, 3 10,724, 10,725, 10,745, and 10,754, into this case. 5 For your convenience, I have pulled out the exhibit book from those prior cases, which were 6 7 consolidated and reheard by you on August 26th. In addition, a copy of our proposed order that we 8 9 submitted in the prior case, so that you'll have the reference points for how to deal with Case 10,855. 10 11 EXAMINER STOGNER: Thank you, Mr. Kellahin. 12 will incorporate into the record in this matter all the above cases which Mr. Kellahin listed. 13 14 Since there is -- or there appears to be nothing else concerning this particular case, I will take Case 15 16 Number 10,855 under advisement. 17 And with that, hearing adjourned. 18 (Thereupon, these proceedings were concluded at 19 10:39 a.m.) 20 21 22 23 24 25
