Reference is made to your application dated March 8, 1994 for an unorthodox Blinebry gas well location in an existing non-standard 80-acre gas spacing and proration unit (GPU) for said Blinebry Oil and Gas Pool comprising the W/2 NE/4 of Section 10, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico. Said GPU was authorized by Division Order No. NSP-995, dated May 9, 1975, and has dedicated thereon the Rollon Brunson Well No. 4 (API No. 30-025-10161), located 2086 feet from the North line and 1874 feet from the East line (Unit G) of said Section 10.

It is our understanding that the subject well in this application is currently a dually completed Tubb gas and Drinkard oil well; however, said well will be plugged back and completed as a single Blinebry gas well upon issuance of this order.




