Dear Mr. Lemay:

Per instruction from Mr. Jerry Sexton in the Hobbs District (fich and enclosed Forms C-101 & C-102 along with a survey plat showing offset operators, a borehole trajectory plot and executed Waivers - all related to our proposed re-entry and sidetrack drilling of the referenced well. In partnership with Middle Bay Oil Company, Inc., BEI intends to re-enter the referenced well to a depth of approx. 8500 to 8700 ft. and drill a new borehole in a northerly direction to a point 50 ft. from the north line of Section 12 at a TVD of 11,700 ft. BEI/Middle Bay own leasehold and will operate the lands identified on the enclosed plat.

RE:

The proposed BHL location will be unorthodox for both the Lovington NE. Wolfcamp Field rules (330' from 40 ac. unit boundary) and the Lovington NE. Penn. Field rules (510' from 80 ac. unit boundary). The planned sidetrack borehold will be 300' FNL at the Wolfcamp formation and 50' FNL at the Strawn formation. We have received approval from the offset operators to our leasehold through the form of written Waiver of our proposed unorthodox location (enclosed). Our research and records indicate that the mineral ownership of the N/2 NE/4 of Section 12 and the S/2 SE/4 of Section 1, T16S, R36E is identical and we feel correlative rights will be protected.






Figure 3. Planned sidetrack borehole trajectory in No.2 Harris well.


