This is a follow up to our letter of August 7, 2002 regarding Marks and Garner's post-hearing submission of evidence.

Although I have spoken with Marks and Garner's counsel concerning the lack of legibility of the copies of log books furnished, and the fact that the material covers only a portion of the relevant time period, no additional material has been furnished. Mr. Bruce has indicated that he has furnished to the Commission and to Division counsel everything he has.

At this time, we would respectfully point out to the Commission the limited coverage of the logbook submitted and numerous apparent changes in the entries, particularly the numbers. Many of the numerical entries appear to have been written over, and we have no explanation of the time or reason for these changes.

OCD respectfully requests a further extension of time till August to respond as directed by the Commission. If we have not had an opportunity to examine any additional material by that time, we will then file our final comments on the materials as received.
