




**ORDER OF DISMISSAL

The above-referenced case is an appeal of a New Mexico Oil Conservation Commission decision brought in the District Court pursuant to NMSA 1978, § 70-2-25(B) and Rule 1-074 NMRA 1998. On April 28, 1998, I received a copy of a brief in chief filed with the Court by the Petitioner-Appellee Fasken Oil and Ranch, Ltd. and Fasken Land and Minerals, Ltd. However, NMSA 1978, § 70-2-25(B) has no reference to briefs to be filed by the parties. It has been the usual practice that the parties to these appeals file briefs based on a briefing schedule set by the District Court.
