Gentlemen:

This office is in receipt of your letter of December 17, 1985, together with copies of the South Lucky Lake Queen Unit Agreement, Chaves County, New Mexico which you have submitted on behalf of Burk Royalty Company. A review of the captioned unit agreement points out the need for further corrections, explanation or elaboration in certain parts of the document.

The unit area is drawn to include 880.00 acres. Of this, Tract 9, an 80.00 acre federal tract is unleased. It is difficult to explain the inclusion of an open federal tract since this makes the United States Government a working interest owner. It is our recommendation that the quickest solution to this problem is to re-draw the unit boundary to eliminate Tract No. 9 from the Unit Area.

Also, there is a complete lack of geologic and engineering data. Such data has an immediate application in determining size and characteristices of the participating area, plan of operation and calculation of participating interests. A crude participation formula has been provided but no data is included to check the equitability of distribution of interests.

A compilation of production data, beginning with 1982, shows that state leases yielded an average 29% of cumulative production but get only a 24.75% participation. This suggests a dilution of state interests.

A third factor in the participation formula involves acre foot reserve and reservoir calculations. Without porosity, water saturation, thickness and area figures, reservoir calculations are only a wild guess. No such data is provided. Also, no logs are provided to demonstrate continuity of the proposed flood zone. There is nothing to show that waterflood would be a practical and efficient means for enhancing recovery from this producing area.

It is incumbent upon the participants to provide supportive data. Until the problem of Tract No. 9 is solved and the geologic data are provided, approval of this proposed unit cannot be justified from a technical standpoint.

Before any approval is made, Burk Royalty Co. should explain the participation factors and also submit the unit operating agreement, an Initial Plan of Operation (as per Section 11 of the agreement) and a redesignation of all well names and numbers.

The following corrections should be made before we give any approval.

- 1. Please submit all ratifications from the Lessees of Record and Working Interest Owners. All signatures should be acknowledged before a Notary and one set must contain original signatures.
- 2. Please submit a schedule showing the total acreage of lands in the Unit. State 160.00 Acres (18.18%) Federal 720.00 Acres (81.82%). This schedule should also break down the committed acreage and the uncommitted acreage.
- 3. The Tract Nos. on Exhibits "A", "B" and "C" should be in numerical order with the Federal tracts listed first and the State tracts listed second. All State tracts should be in chronological order.
- 4. On Exhibit "B", Tract No. 6, the correct land description should be SE\(\frac{1}{2}\)Section 16-15S-R29E. The correct Lease No. should be L-1894-1 and the expiration date should be 12-17-78. The Lessee of Record should also be corrected to Read and Stevens, Inc.
- 5. On Exhibit "B" page 1, Tract No. 7 was apparently split up due to the Working Interest Owners, however it might be possible to combine the two tracts as per Exhibit "A". The correct land description of this tract should be NW4SE4 Sec. 16-T15S-R29E (delete N/2). The correct Lease No. should be K-5110-1 and the expiration date is 7-20-75 and the Lessee of Record should be New Mexico Oil Corp.
- 6. On Exhibit "B" page 2, Tract No. 7, if this Tract can not be combined with the Tract No. 7 on page 1, this Tract should be given another Tract Number or should be designated as Tract No. 7a. The correct land description for this tract should be SW\(\frac{1}{2}\)Section \(\frac{1}{2}\)6-T15S-29E & (delete S/2). The correct Lease No. should be K-5110-1, the expiration date should be 7-20-75 and the Lessee of Record should be \(\frac{New Mexico}{2}\)0il Corp.
- 7. On Exhibits "A" and "B" Tract No. 8, the correct Lease No. should be L-1894-1, the expiration date should be 12-17-78 and the correct Lessee of Record should be Read and Stevens, Inc.
- 8. It appears that Exhibits "A" "B" and "C" should be revised as applicable to reflect the above changes.
- 9. On page 6 of the Unit Agreement, Section (1) should include the Land Commissioner as noted on your copy.
- 10. On page 10 of the Unit Agreement, Section 11, on the last paragraph should also include the Land Commissioner as noted.

- 11. Section 23 of the Unit Agreement makes reference to an expiration date of November 1, 1985. Please advise if this date has been extended.
- 12. The filing fee for a Unit Agreement is Thirty (\$30.00) Dollars per section or partial section thereof. Please submit a filing fee in the amount of \$180.00 Dollars.
- 13. Any approval will be conditioned upon subsequent favorable approval by the New Mexico Oil Conservation Division and the Bureau of Land Management.




