ORDER OF THE OIL CONSERVATION COMMISSION

BY THE COMMISSION:

THIS MATTER came before the Oil Conservation Commission (the Commission) for hearing on June 17, 2004 at Santa Fe, New Mexico on San Juan Coal Company's Motion to Withdraw or Dismiss, and the Commission, having carefully considered the same, now, on this 17th day of June, 2004,


FINDS,

1. Notice has been given of the application and the hearing on this matter, and the Commission has jurisdiction of the parties herein.
2. A hearing was held before the Commission on this matter on June 4, 2003. Subsequent to the hearing, the parties, San Juan Coal Company and **Dugan** Production Corporation, advised the Commission that they had reached agreement concerning the matters in controversy between them.
3. The Commission therefore finds, in accordance with the settlement agreement between the parties, that the appeal of San Juan Coal Company should be dismissed with prejudice as to Dugan Production Corporation, but without affecting the positions asserted by San Juan Coal Company in Case No. 12734, which is currently pending.

IT IS THEREFORE ORDERED THAT:

1. The appeal of San Juan Coal Company in this case is dismissed with prejudice as to Dugan Production Corporation.
2. Division Order No. R-8768-C shall remain in force and effect as to the lands covered by this Order.
3. This Order shall have no precedential, *res judicata*, collateral estoppel or other effect on the positions asserted by San Juan Coal Company in Case No. 12734 (*de novo*), or any related review or appeals that may arise therefrom, or any similar proceedings involving parties other than Dugan Production Corporation.
4. Jurisdiction is hereby retained for the entry of such further orders as the Division may deem necessary.
