**APPLICATION OF CHI ENERGY, INC. FOR COMPULSORY POOLING,  
EDDY COUNTY, NEW MEXICO.**

**ORDER OF THE DIVISION**

**BY THE DIVISION;**

This case came on for hearing at 8:15 a.m. on November 18, 2004, and January 6, 2005, at Santa Fe, New Mexico, before Examiner David R. **Catanach**.

NOW, on this 12<sup>th</sup> day of January, 2005, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

**FINDS THAT:**

(1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.

(2) The applicant, Chi Energy, Inc. ("applicant") seeks an order pooling all uncommitted mineral interests from the surface to the base of the Morrow formation underlying the N/2 of Section 33, Township 22 South, Range 27 East, **NMPM**, Eddy County, New Mexico, to form a standard **320-acre** spacing and proration unit for any formations **and/or** pools spaced on 320 acres within this vertical extent which presently include but are not necessarily limited to the **Undesignated East Carlsbad-Wolfcamp** Gas Pool, **Undesignated South Carlsbad-Strawn** Gas Pool, **Undesignated South Carlsbad-Morrow** Gas Pool, **Undesignated Cass Draw-Wolfcamp** Gas Pool and **Undesignated Otis-Atoka** Gas Pool.

(3) The above-described unit ("the Unit") is to be dedicated to the applicant's Otis "33" Well No. 2 (API No. 30-015-24810) which is proposed to be re-entered at a previously-approved unorthodox gas well location (approved only for the East **Carlsbad-Wolfcamp** and South Carlsbad-Morrow Gas Pools by Division Order No. **NSL-5103** dated August 31, 2004) 990 feet from the North line and 2130 feet from the West line (Unit C) of Section 33.

(4) Two or more separately owned tracts are embraced within the Unit, **and/or** there are royalty interests **and/or** undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.

(5) Applicant is an owner of an oil and gas working interest within the Unit. Applicant has the right to and proposes to re-enter the Otis "33" Well No. 2 to test the Wolfcamp, Morrow and other formations spaced on 320 acres within the Unit.

(6) There are interest owners in the proposed Unit that have not agreed to pool their interests.

(7) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.

(8) At the request of the applicant, Chi Operating, Inc. should be designated the operator of the subject well and of the Unit.

(9) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus an additional 200% thereof as a reasonable charge for the risk involved in re-entering the well.

(10) Reasonable charges for supervision (combined fixed rates) should be fixed at \$6,000.00 per month while conducting re-entry operations and \$600.00 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "*Accounting Procedure-Joint Operations.*"

**IT IS THEREFORE ORDERED THAT ;**

(1) Pursuant to the application of Chi Energy, Inc., all uncommitted mineral interests from the surface to the base of the Morrow formation underlying the N/2 of Section 33, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico, are hereby pooled to form a standard 320-acre spacing and proration unit for any formations **and/or** pools spaced on 320 acres within this vertical extent which presently include but are not necessarily limited to the Undesignated East **Carlsbad-Wolfcamp** Gas Pool, Undesignated South **Carlsbad-Strawn** Gas Pool, Undesignated South Carlsbad-Morrow Gas Pool, Undesignated Cass **Draw-Wolfcamp** Gas Pool and Undesignated Otis-Atoka Gas Pool.

The above-described Unit shall be dedicated to the applicant's Otis "33" Well No. 2 to be re-entered at a previously approved unorthodox gas well location 990 feet from the North line and 2130 feet from the West line (Unit C) of Section 33.

(2) The operator of the Unit shall commence re-entry operations on the well on or before April 15, 2005 and shall thereafter continue conducting re-entry operations with due diligence to test the Morrow formation.

(3) In the event the operator does not commence re-entry operations on the well on or before April 15, 2005, Ordering Paragraph (1) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause.

(4) Should the subject well not be re-entered and completed within 120 days after commencement thereof, Ordering Paragraph (1) shall be of no further effect, and the Unit created by this Order shall terminate unless the operator appears before the Division Director and obtains an extension of time to complete the well for good cause demonstrated by satisfactory evidence.

(5) Upon final plugging and abandonment of the subject well, the pooled Unit created by this Order shall terminate, unless this order has been amended to authorize further operations.

(6) Chi Operating, Inc. is hereby designated the operator of the subject well and of the Unit.

(7) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including **unleased** mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of re-entering, completing and equipping the subject well ("well costs").

(8) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."

(9) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the **45-day** period, the Division will determine reasonable well costs after public notice and hearing.

(10) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.

(11) The operator is hereby authorized to withhold the following costs and charges from production:

- (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and

- (b) as a charge for the risk involved in re-entering the well, 200% of the above costs.

(12) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.

(13) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$6,000.00 per month while conducting re-entry operations and \$600.00 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "*Accounting Procedure-Joint Operations*." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.

(14) Except as provided in Ordering Paragraphs (11) and (13) above, all proceeds from production from the well that are not disbursed for any reason shall be placed in escrow in Eddy County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division of the name and address of the escrow agent within 30 days from the date of first deposit with the escrow agent.

(15) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.

(16) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.


(17) The operator of the well and Unit shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.

(18) The applicant shall be required to obtain additional non-standard gas well location approval for the Otis "33" Well No. 2 in the event that the well is completed in a gas pool not authorized by Division Order No. NSL-5103.

(19) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
