#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on March 16, 2006, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 30<sup>th</sup> day of March, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

#### **FINDS THAT:**

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Atoka formation, bearing the designation of Northwest Austin-Atoka Gas Pool (**Pool** Code 97481). The Northwest Austin-Atoka Gas Pool was discovered by the Threshold Development Company Alma 33 State Well No. 1 (**API** No. 30-025-36668) located in Unit F of Section 33, Township 13 South, Range 35 East, NMPM, which was completed in the Atoka formation on August 11, 2004. The top of the perforations is at 12,908 feet.
- (3) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Grayburg formation, bearing the designation of West Corbin-Grayburg Pool (Pool Code 97488), The West Corbin-Grayburg Pool was discovered by the Harvey E. Yates Company Shoot 12 Federal Well No. 3 (API No. 30-025-31101) located in Unit O of Section 12, Township 18 South, Range 32 East, NMPM,

which was completed in the Grayburg formation on July 17, 2005. The top of the perforations is at 4,738 feet.

- (4) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Morrow formation, bearing the designation of East Hightower-Morrow Gas Pool (Pool **Code** 97502). The East Hightower-Morrow Gas Pool was discovered by the Yates Petroleum Corporation Wynona State Unit Well No. 1 (**API** No. 30-025-37013) located in Unit A of Section 20, Township 12 South, Range 34 East, NMPM, which was completed in the Morrow formation on December 5, 2005. The top of the perforations is at 12,100 feet,
- (5) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Hobbs-Wolfcamp Pool (Pool Code 97477). The Hobbs-Wolfcamp Pool was discovered by the Oxy USA WTP LP. State A Well No. 11-Y (API No. 30-025-37349) located in Unit J of Section 29, Township 18 South, Range 38 East, NMPM, which was completed in the Wolfcamp formation on August 20, 2005. The top of the perforations is at 7,702 feet.
- (6) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the San Andres formation, bearing the designation of East Midway-San Andres Pool (**Pool Code** 97486). The East Midway-San Andres Pool was discovered by the Yates Petroleum Corporation Bureaucrat AGV Well No. 1 (**API** No. 30-025-30767) located in Unit F of Section 14, Township 17 South, Range 37 East, NMPM, which was completed in the San Andres formation on September 14, 2005. The top of the perforations is at 5,272 feet.
- (7) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of East Osudo-Wolfcamp Pool (**Pool Code** 97483). The East Osudo-Wolfcamp Pool was discovered by the Chesapeake Operating Inc. CC 3 State Well No. 1 (**API** No. 30-025-36794) located in Unit M of Section 3, Township 21 South, Range 35 East, NMPM, which was completed in the Wolfcamp formation on March 25, 2005, The top of the perforations is at 10,690 feet.

#### IT IS FURTHER ORDERED THAT:

- (1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations and extensions included herein shall be April 1, 2006.
