Gentlemen:

The first revision to the Delaware Formation Participating Area "A", NMNM068294N (formerly known as Cherry Canyon Formation PA "A") is hereby approved effective as of August 1, 2014, pursuant to Section 11 of the Big Eddy Unit Agreement, Eddy County, New Mexico.

This revision enlarges the Delaware Formation Participating Area "A" from 40.00 acres to 400.00 acres and is based upon the completion of unit well No. DI 5 4H, located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ (SHL) of Section 27, unit tract No. 78, Lease No. NMLC065431, and in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ (BHL) of Section 25, T.20S., R.31E., unit tract No. 88A, Lease No. NMLC065914, with an initial potential of 368 BOPD and 0 MCFPD, from the Delaware Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the first revision to the Delaware Formation Participating Area "A" effective as of August 1, 2014.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 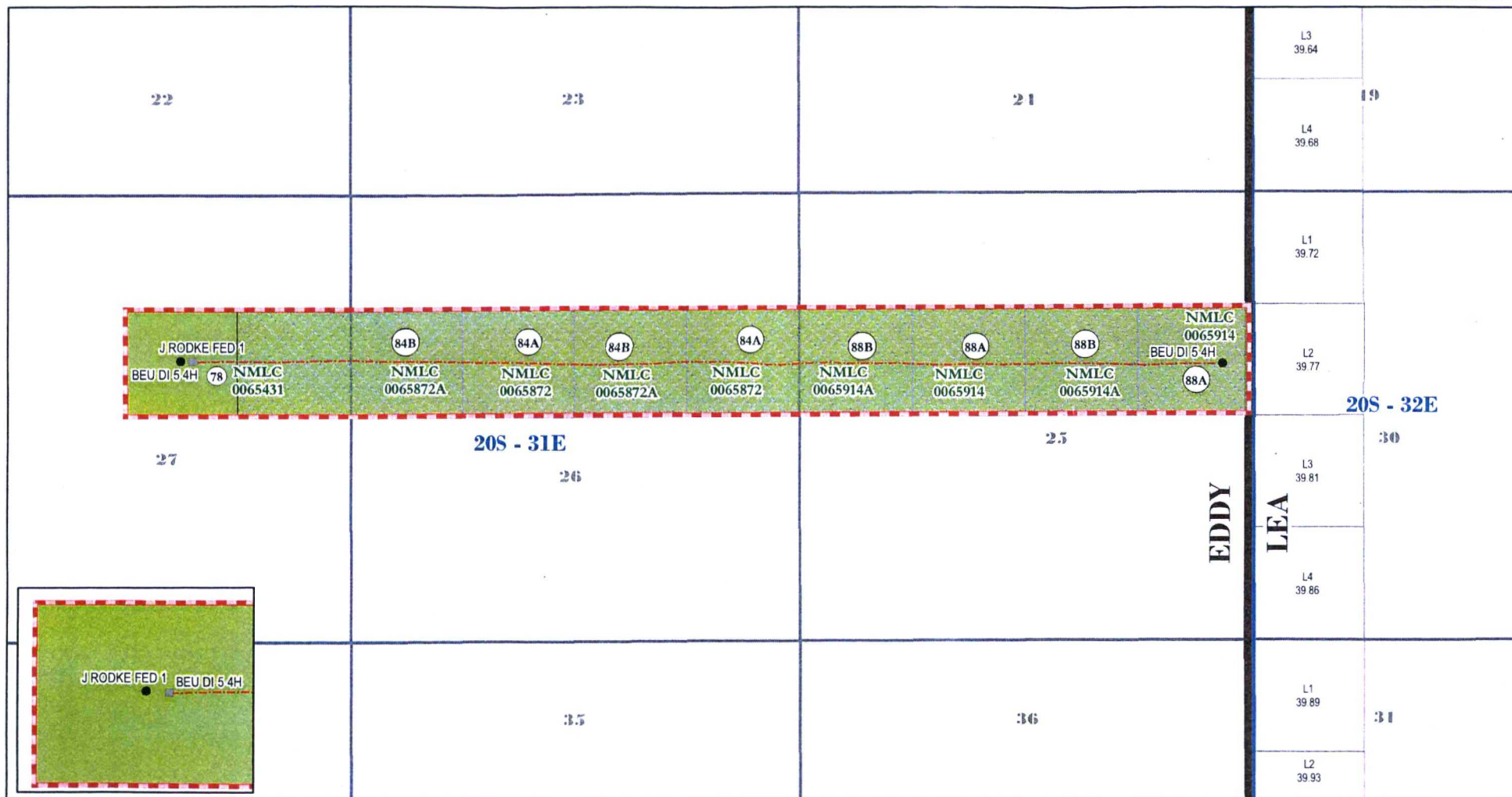

EFFECTIVE AUGUST 1, 2014



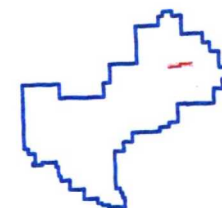
