Pursuant to Section 10 of the San Juan Lindrith Unit Agreement, Hilcorp Energy Company ("Hilcorp"), as Unit Operator, hereby submits the proposed 2019 Plan of Development and Operations ("POD").

I. PERIOD

This plan will be effective from April 1, 2019 through March 31, 2020. The 2020 Plan will be submitted on or before March 1, 2020.

II. 2018 PLAN REVIEW OF OPERATIONS

A summary of key activities undertaken after August 1, 2018 include:

A. Production History: During 2018, cumulative production from the San Juan 28-6 Unit was 14.3 BCF gas; 32.7 MBO oil; and 63.2 MBW produced water. Refer to the attached Exhibit A for the wells in the Lindrith 'B' Unit.
