THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, EXTENDING VERTICAL AND HORIZONTAL LIMITS, AND REDESIGNATING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 14, 2006. at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 20<sup>th</sup> day of September, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

#### **FINDS THAT**:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Deadman Draw-Wolfcamp Gas Pool (Pool Code 97536). The Deadman Draw-Wolfcamp Gas Pool was discovered by the Marathon Oil Company Indian Hills Unit Well No. 50 (API No. 30-015-32350) located in Unit K of Section 16, Township 21 South, Range 24 East, NMPM, which was completed in the Wolfcamp formation on May 19, 2006. The top of the perforations is at 7,610 feet.
- (3) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of South Greenfield-Wolfcamp Gas Pool (**Pool Code** 97538). The South Greenfield-Wolfcamp Gas Pool was discovered by the Yates Petroleum Corporation Hackey Sack

"BHV" Federal Com. Well No. 1 (**API** No. 30-005-63798) located in Unit D of Section 4, Township 14 South, Range 27 East, NMPM, which was completed in the Wolfcamp formation on May 7, 2006. The top of the perforations is at 5,616 feet.

- (4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Bone Spring formation, bearing the designation of East Happy Valley-Bone Spring Pool (**Pool Code 97541**). The East Happy Valley-Bone Spring Pool was discovered by the Kaiser-Francis Oil Company Mesa "11" Grande Well No. 2 (**API** No. 30-015-33720) located in Unit L of Section 11, Township 22 South, Range 26 East, NMPM, which was completed in the Bone Spring formation on May 17, 2006. The top of the perforations is at 6,321 feet.
- (5) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Mississippian formation, bearing the designation of Indian Basin-Mississippian Gas Pool (**Pool Code** 97537), The Indian Basin-Mississippian Gas Pool was discovered by the Marathon Oil Company Indian Hills Unit Well No. 50 (**API No. 30-015-31655**) located in Unit L of Section 20, Township 21 South, Range 24 East, NMPM, which was completed in the Mississippian formation on December 26, 2005. The top of the perforations is at 10,406 feet.
- (6) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Red Tank Draw-Wolfcamp Pool (**Pool Code** 97535). The Red Tank Draw-Wolfcamp Pool was discovered by the David H. Arlington Oil and Gas, Inc. Green Wooley Booger 5 Federal Well No. 1 (**API No. 30-015-31498**) located in Unit L of Section 5, Township 19 South, Range 24 East, NMPM, which was completed in the Wolfcamp formation on March 7, 2006. The top of the perforations is at 4,776 feet.
- (7) There is need for the extension of the vertical limits of the Cedar Lake-Yeso Pool (**Pool Code 96831**) in Eddy County, New Mexico to include the top of the Glorieta formation and continue down to the top of the Abo formation and the redesignation of the pool as the Cedar Lake-Glorieta-Yeso Pool (**Pool Code 96831**).
- (8) There is need for the extension of the vertical limits of the Fren-Paddock Pool (**Pool Code** 26770) in Eddy County, New Mexico to include the top of the Glorieta formation and continue down to the top of the Abo formation and the redesignation of the pool as the Fren-Glorieta-Yeso Pool (**Pool Code** 26770).
- (9) There is need for the extension of the vertical limits of the East Fren-Paddock Pool (**Pool Code 97213**) in Eddy County, New Mexico to include the top of the Glorieta formation and continue down to the top of the Abo formation and the redesignation of the pool as the East Fren-Glorieta-Yeso Pool (**Pool Code** 97213).
- (10) There is need for the extension of the vertical limits of the Loco Hills-Paddock Pool (**Pool Code 96718**) in Eddy County, New Mexico to include the top of the

Glorieta formation and continue down to the top of the Abo formation and the redesignation of the pool as the Loco Hills-Glorieta-Yeso Pool (**Pool Code** 96718).

(11) There is need for extensions to the Artesia-Glorieta-Yeso Pool, the East Black River-Wolfcamp Gas Pool, the Bunting Ranch-Morrow Gas Pool, the Cedar Canyon-Delaware Pool, the Cemetery-Morrow Gas Pool, the Northeast Collins Ranch-Wolfcamp Gas Pool, the South Corral Canyon-Bone Spring Pool, the Cottonwood Creek-Wolfcamp Gas Pool, the West Cottonwood Creek-Wolfcamp Gas Pool, the Northeast Fren-Morrow Gas Pool, the Golden Lane-Morrow Gas Pool, the Gopher-Wolfcamp Gas Pool, the Happy Valley-Strawn Gas Pool, the Logan Draw-Morrow Gas Pool, the Nash Draw-Delaware/Bone Spring-Avalon Sand Pool, the P.O.W.-Morrow Gas Pool, the East Pierce Crossing-Bone Spring Pool, the Salt Draw-Morrow Gas Pool and the Wye-Delaware Pool, all in Eddy County, New Mexico; and the Coyote-Wolfcamp Gas Pool in Chaves County, New Mexico.

#### IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the Deadman Draw-Wolfcamp Gas Pool (**Pool Code** 97536), consisting of the following described area:

(b) A new pool in Chaves County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the South Greenfield-Wolfcamp Gas Pool (**Pool Code** 97538), consisting of the following described area:

(c) A new pool in Eddy County, New Mexico classified as an oil pool for Bone Spring production is hereby created and designated as the East Happy Valley-Bone Spring Pool (**Pool Code 97541**), consisting of the following described area:

(d) A new pool in Eddy County, New Mexico classified as a gas pool for Mississippian production is hereby created and designated as the Indian Basin-Mississippian Gas Pool **(Pool Code** 97537), consisting of the following described area:

#### IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, extensions of vertical and horizontal limits, and redesignations included herein shall be October 1, 2006.
