PRE-HEARING ORDER

FINDS that the Commission has jurisdiction of the parties and the subject matter herein and that entry of a Pre-hearing Order in this matter is in the best interests of administrative economy and will assist in rendering a complete, coherent and fair hearing of this matter.

IT IS THEREFORE ORDERED, AS FOLLOWS:

1. Dates of Hearing. The hearing will commence at 9:00 a.m. on Thursday, September 11, 2003 and continue, as necessary, through Friday, September 12, 2003.

- **2. Place of Hearing.** Porter Hall, 1220 S. St. Francis Drive, Santa Fe, New Mexico.
- **3. Division Proposal.** The focus of the hearing will be the proposed rules filed by the Division staff in this Case No. 12969 on August **18**, 2003. - **4. Deadline for Filing Written Comments and Proposed Amendments.** Written comments on the proposed rules, and any proposals for amendments thereto or substitutions therefor, must be received by the Division Administrator at the above address not later than 5:00 p.m. on Monday, September 8, 2003.
- 5. **Pre-Hearing Statements.** Any person, other than the Division, desiring to present **technical testimony** in support of, or in opposition to, the proposed rules shall file a **pre-hearing** statement substantially in the form provided for **pre-hearing** statements in adjudicatory hearings (See Division Rule 1208.B [19.15.1208.B NMAC]). Pre-hearing statements must be received by the Division Administrator at the above address not later than 5:00 p.m. on Monday, September 8, 2003.
- 6. Order of Presentations and Evidence. The hearing will begin with a technical presentation by the Division staff in support of the proposed rules. Following the Division's presentation, the Commission will entertain presentations by other parties and public comments. All persons present at the hearing and desiring to address the Commission regarding the proposed rules will be accorded a reasonable opportunity to speak. The order of presentation will depend on the number and length of proposed presentations and comments and will be determined by the Commission on the day of the hearing.
- **7. Post-Hearing Submissions.** The Commission will make a decision at the close of the hearing whether additional written comments on the proposed rules or proposals for amendments thereto or substitutions therefor will be accepted after the close of the hearing and, if it decides to accept such submissions, will then fix a final closing date for submission thereof.
