IN THE MATTER OF THE HEARING CALLED BY THE NEW MEXICO OIL CONSERVATION DIVISION ("DIVISION") ON ITS OWN MOTION FOR AN ORDER REQUIRING PLAYA MINERALS & ENERGY INC. TO PROPERLY PLUG ONE HUNDRED THIRTY-FOUR (134) WELLS, IMPOSING CIVIL PENALTIES AND AUTHORIZING THE DIVISION TO PLUG SAID WELLS AND TAKE APPROPRIATE MEASURES TO SEEK REIMBURSEMENT FROM ANY SECURITY FURNISHED BY OPERATOR IN EVENT OF OPERATOR'S FAILURE TO COMPLY

ORDER OF THE DIVISION

BY THE DIVISION;

This case came on for hearing at 8:15 a.m. on June 19, 2003, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 11th day of September, 2003, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.
- (2) The New Mexico Oil Conservation Division ("Division") on its own motion seeks an order directing **Playa** Minerals & Energy, Inc. of Houston, Texas, to plug the wells described in the attached Exhibit "A" located in San Juan County, New Mexico, in accordance with a Division-approved plugging program.
- (3) Should Playa Minerals & Energy, Inc. fail to plug and abandon these wells, the Division seeks an order authorizing the Division to plug and abandon these wells and: (i) declare forfeiture of any security posted by Playa Minerals & Energy, Inc. to the extent necessary to fully reimburse the Division for its expenses incurred in accomplishing the foregoing; and (ii) take necessary and appropriate measures to recover from Playa Minerals & Energy, Inc. any costs of plugging these wells in excess of the amount of the security, if any.

- (4) Playa Minerals & Energy, Inc. was not present and was not represented by legal counsel at the hearing.
- (5) BC&D Operating, Inc. from Hobbs, New Mexico, made an appearance at the hearing through an attorney and one witness and presented the following testimony:
 - (a) Property Management and Consulting, Inc. of Farmington, New Mexico was appointed by the courts as a receiver for the assets of Playa Minerals and Energy, Inc. Subsequently, Property Management and Consulting, Inc. approached BC&D Operating, Inc. for basic cleanup activity on the Horseshoe Gallup Unit;
 - (b) the last month of production for any well on this Horseshoe Gallup Unit was April of 2001, and the Unit has been abandoned since then;
 - (c) well No. 4 is an injection well and was used approximately 45 days prior to this hearing to dispose of tank water;
 - (d) Vulcan Minerals and Energy Inc. is the same company as Playa Minerals & Energy, Inc., which is a wholly owned subsidiary of Regent Energy;
 - (e) the United States Bureau of Land Management has taken action to dissolve this Unit and cancel the oil and gas leases within the Unit boundaries; and
 - (f) these wells should be plugged and abandoned for protection of the environment and prevention of waste.
 - (6) The Division presented evidence and testimony that:
 - (a) the Horseshoe Gallup Unit was originally drilled by **Arco** and has been transferred to a new operator several tunes over the years;
 - (b) the current operator of record is Playa Minerals and Energy, Inc., which is shown in the official records of the New Mexico Public Regulation Commission as a forfeited, non-appealable, terminated corporation, and there is no evidence that the name, Playa Minerals and Energy, Inc., has been changed to Vulcan Minerals and Energy, Inc;
 - (c) the last month of reported production for any of these wells was February 2002;

- (d) the Aztec District Office of the Division has plugged six wells that were uncontrollably leaking to the surface and had holes in the upper casing opposite a water zone; the District also bled off all wells and installed new valves to prevent inflow into a leaking tank battery;
- (e) the wells to be plugged under this order are located on the Navajo Nation, Federal public domain lands and State of New Mexico lands, and none are located on the Ute Mountain Ute Indian Nation; none of the wells to be plugged are located near the disputed territory between the Navajo Nation and the Ute Mountain Ute Nation;
- (f) a Division-approved plugging procedure for each of these wells has also been approved by the United States Bureau of Land Management;
- (g) a public water supply well was installed by the United States Geological Survey in this area, but otherwise fresh water is considered very limited;
- (h) the applicant's exhibits relating to well history were correct in this matter; and
- (i) these wells should be plugged as soon as possible to protect the environment and prevent waste.
- (7) Evidence was not presented at the hearing showing the type or amount of security bond posted by Playa Minerals and Energy, Inc.
- (8) By virtue of the failure to use these wells for beneficial purposes or to obtain approval for temporary abandonment, and its discontinuance of operation and supervision of these wells, Playa Minerals & Energy, Inc. is presumed to have abandoned the subject wells.
- (9) The current condition of these wells is such that if action is not taken to properly plug and abandon the wells, waste will probably occur, correlative rights will be violated, livestock and wildlife may be subject to harmful contaminants, and existing fresh waters may be in danger of contamination.

IT IS THEREFORE ORDERED THAT;

- (1) Pursuant to the application of the New Mexico Oil Conservation Division ("Division"), Playa Minerals & Energy, Inc. of Houston, Texas, is hereby ordered on or before November 1, 2003, to plug and abandon the wells described in Exhibit "A" in accordance with a Division approved plugging program.
- (2) If Playa Minerals & Energy, Inc. fails to bring these wells into compliance as required by this Order, the Division may then take such actions as are necessary to cause these wells to be properly plugged and abandoned. Further, the Division shall then be authorized to take such action as is deemed necessary to: (i) declare forfeiture of any security posted by Playa Minerals & Energy, Inc., to the extent necessary to fully reimburse the Division for its expenses incurred in accomplishing the foregoing; and (ii) recover from Playa Minerals & Energy, Inc. any costs of plugging the subject wells in excess of the amount of this security, if any.
- (3) Failure to comply with the provisions of this order shall subject Playa Minerals & Energy, Inc. to a fine of \$1,000 per day, commencing from the date of this order until such work is completed (NMSA 1978, Section 70-2-31, as amended).
- (4) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
