3/25/2020 Cleared location. Moved in rig and spotted the rig over the hole. Moved flowline away from wellhead.

3/26/2020 Moved in remaining equipment and rigged up. Laid down 83 $\frac{3}{4}$ " rods. Pumped 20 bbls down the 5 $\frac{1}{2}$ " casing and installed BOP. Laid down 68 joints of 2 $\frac{3}{8}$ " tubing. Rigged up wireline and made a gauge ring run to 1800' without issue. Moved in workstring and SION.

3/27/2020 Set CIBP @ 1753'. Tagged CIBP with workstring. Circulated MLF and tested casing. Casing good to 550#. Spot 50 sx Class C on top of CIBP. POOH to 428' and circulated cement to surface with 50 sx Class C. Rigged down. Dug out and cut off wellhead. Filled up both string of casing with less than 1 sack of cement. Installed marker, removed anchors, cleaned the pit and cleared location.
