This well was plugged as follows:

- 6/19/20: Pull tubing and packer out of hole.
- 6/22/20: RU Wireline, Set CIBP @ 8760' and dump 35' cement on top. RIH and tag 8722'. **Plug #1 CIBP and class H cement from 8722 to 8760'**. Pump 60 bbls 9.5# plugging mud and perf 5429'.
- 6/23/20: RIH to 5730', pump 35 sx cement, attempt squeeze 500 psi without success. RIH and perforate 3349'
- 6/24/20: Tag plug 2 @ 5426' (low), pumped another 25 sx @ 5426'.
- 6/25/20: RIH and tag plug 2 @ 5227'. **Plug #2 60 sx class C 5227 to 5730'**. Pull 35 jts and SDFWE.
- 7/13/20: RIH w/ tubing to 3370' and pumped 55 bbls 9.5# plugging mud. Pump 35sx and squeeze into perforations. POH and perf 1959'
- 7/14/20: RIH and tag plug 3 @ 3212'; **Plug 3 35sx class C 3212 to 3370'**. Pull up to 1975', pump 35 sx and squeeze into perfs. Perf @ 400'
- 7/15/20: Tag plug 4 @ 1706'. **Plug #4 34 sx 1706-1975'**.
- 7/16/20: Pumped 110 sx cement into perfs at 400' to fill 4 1/2" and annulus between 8 5/8". **Plug #5 110 sx class C Surface to 400'**.
- 7/21/20: Cut off 13 3/8", 8 5/8" and 4 1/2" casings 2" below ground level. Weld plate and dry hole marker.
