Dear Mr. Lowe:

Included with this letter are the following documents demonstrating that the above referenced well will be drilled at a standard oil well location:

- C-102 Plat dated June 10, 2022, showing the as-drilled location of the Almost Eddy 30 Fed Com 504H, respectively;
- "Area of Common Ownership Plat" separately showing the spacing units for the well; and
- Certification of Ownership demonstrating the outlined area on the plat is comprised of two federal leases, with uniform ownership.

19.15.16.15.C(7) NMAC provides that in area of common ownership (here, two federal leases) the setback requirements only apply to the outer boundary of the area of uniform ownership, not the spacing unit within the area of uniform ownership. Since the area to the east towards which this well encroaches is within the documented "area of common ownership," this well is at a standard location and approval of a non-standard location for the well is not necessary.




