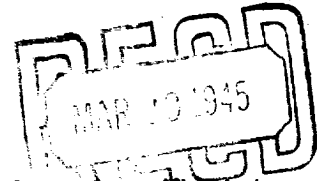

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Will mud back and place 10 sacks cement just below 8-5/8" Casing at 1440' - pull 8-5/8" and then place heavy mud back toward 10-3/4" at 800' and place 10 sacks cement just below pipe; pull 10-3/4"; will then place heavy mud back to 400' and run 10 sacks cement; place heavy mud back to top and run 5 sacks cement on top of hole. 4" by ~~19~~" marker will be put at mouth of well.
