02/13/02 Spud @ 7:00 a.m. Drill 11" surface hole to 310'.
 Run 15 jts. of 8-5/8" 23 ppg to 303'. Halliburton mixed and pumped 90 sx Midcon II PP, 14.0 ppg, with 6% salt, 5#/sx gilsonite & 0.3% versaset at 3 bpm with 100 psi. Circulated 5 bbls of cement to surface.
 WOC 8 hrs. Test surface casing to 500 psi for 30 minutes.

02/14/02 Drill 7 7/8" hole from 310'-2785'. Reached TD at 11:30 a.m.
 Schlumberger logged well. Ran 66 jts of 5 1/2", 15.5#, M-50 LT & C casing. Set casing at 2747'.
 Halliburton mixed and pump 20 bbl gel pre flush at 3 bpm with 5 psi, 5 gal LGC-8, 120# magmafiber, 100 # baracarb with 5 bbl water spacer. Pumped 370 sx Midcon II, 13 ppg, yield 2.04 at 3 bpm with 15 psi, 6% salt, 2 lb/sx Granulite, 5 lb/sx Gilsonite, .3% Versaset, and .3% Super CBL. Plug down @ 12:30 a.m. with 2400 psi.
 A show of cement at the surface. Well shut in.
