On 2-8-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 8:00 a.m. Drilled to a TD of 704' and ran 8-5/8" casing set at 704'. Cemented with 500 SX Class H cement. Plugged down 2:00 a.m. 2-10-81. Circulated 200 SX. WOC 19 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2445' and ran 5-1/2" casing set at 2445'. Cemented with 935 SX Class H cement. Plugged down 5:00 a.m. 2-19-81. Circulated 215 SX. Currently waiting on completion unit.
