On 3-4-81 CRC Colorado Drilling (Rig #77) spudded a 12-1/4" hole at 6:45 p.m. Drilled to a TD of 703' and ran 8-5/8" casing set at 703'. Cemented with 500 SX Class H cement. Plugged down 11:55 a.m. 3-6-81. Circulated 71 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2830' and ran 5-1/2" casing set at 2830'. Cemented with 1000 SX Class H cement. Plugged down 1:30 a.m. 3-13-81. Circulated 280 SX. Currently waiting on completion unit.
