### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

A leak of low pressure gas between 5 $\frac{1}{2}$ " production string and 13 3/4" surface casing was noticed. Halliburton Cementing Company truck #2174 in charge of G. R. Roach was sent for and 180' of 1" tubing inserted between these pipes and 242 sacks of cement were pumped in, completely closing off this gas. Tubing left in hole and cleared in case similar trouble noticed work can be done from outside again. Suggested by Halliburton.
