The subject well was spudded in April 26, 1977. On May 5, 1977, 7", 17# casing was set at 571' and cemented with 85 sacks of Type II cement. On May 11th, the subject well was drilled to 825' and logged. May 12th, the well reached a T.D. of 1050 feet and the drilling rig was released.
