




CO2 gas was vented to replace a 6" block valve on a lateral of the trunk line on Leg 9 of Bravo Dome CO2 Gas Unit Collection System. Wells were shut in, trunk line and lateral block valves were closed to minimize vent, and lines were bled down to atmosphere. There was no produced water lost.


