Good Morning,

NMOCD did receive your Initial C-141 for the New Mexico State X Oil Well.

In response to your Initial C-141 which was dated 8/11/2016, NMOCD conducted an on-site inspection on 8/4/2016. It was observed and noted that the spill was both historic and recent in nature, as the separator was leaking on the day of inspection. NMOCD is requiring the following:

- A.) Verify Depth to Ground Water via NMOSE
- B.) Discrete Samples be taken
- C.) Delineation and Remediation work plan needs to be submitted by 10/23/2016, as this site needs immediate attention.
- D.) Notify NMOCD prior to sampling to provide opportunity for sample witnessing.

An electronic copy of the Initial C-141 will be uploaded to NMOCD website Administrative/Environmental Orders.
