Ms. Owen,

The OCD has reviewed and accepts the deferral request for the Legacy Reserves, Lea Unit #8D (1RP-5201). However, to complete closure at the time of abandonment, the OCD requests that additional sampling take place to ensure full soil characterization and remediation of areas in-between the currently remediated locations.

These locations will include, but are not limited to the areas in-between DP-2 and DP-6, the areas in-between DP-7 and DP-8, along with the areas between DP-8 and DP-12.

The request stems from concerns regarding soil sample results in which hydrocarbon concentrations fluctuated with depth (i.e. DP-8). Because of the variability within the soil results, the OCD feels that there is some potential for contamination to be present at depth in the areas not represented within the confines of the zones already remediated.

On the other hand, no additional work is required at this time and the site is considered deferred until such time that it is decommissioned.
