The Oil Conservation Division (OCD) has received your request, dated May 21, 1993, for authorization to discharge approximately 591,360 gallons of waste water from the hydrostatic test of a section of new pipeline (30" Loop Line) near Eunice, New Mexico.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. The test water will be discharged into the partially backfilled excavation ditch to allow for safe settling of the pipe and soil.
2. The pipe must be new and never previously used for oil and/or gas transmission.
3. Fresh water will be used to conduct the test.

Pursuant to WQCC Regulation 3-106.B, this approval will allow you to discharge without an approved discharge plan for a period not to exceed 120 days. 
