The Oil Conservation Division (OCD) has evaluated your request dated July 29, 1993 to discharge approximately 153,300 gallons of waste water from the hydrostatic test of a 0.9 mile section of used pipeline (MB 22" Loop purchased from Williams Field Services) near Achuleta, New Mexico.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. The test water will be stored in steel tanks prior to injection into a Class II well.

3. No test waters will be discharged to the surface upon completion of the test.







The Oil Conservation Division (OCD) has received your request, dated October 13, 1992, for authorization to discharge approximately 357,000 gallons of waste water generated from the hydrostatic test of the 22" Trunk MB Loop pipeline in San Juan County, New Mexico. 2. Any solids that accumulate in the bottoms of these frac tanks will be disposed of at an OCD approved disposal site.


