Ms Kieling,

ConocoPhillips Midstream operations in Eddy County is in the process of reactivating one of our gas gathering pipelines to service our Zia Gas Plant which will require a hydro test to insure integrity. The line is located in Sec 29,32, and 33 of 18S-31E, also in Sec 4-19S-31E. It is a 4", 0.250" wall thickness steel pipeline approx. 7,800' long. The procedure will require 121.23 BBLS of water, which will also be the estimated volume to dispose. The water to be utilized for the test will originate from the town of Lovington municipal water supply and will be stored on location after the test until approval from your office is granted to remove by truck for disposal at the Loco Hills SWD facility, OCD permit # R6811B. Thank you for considering our request.
