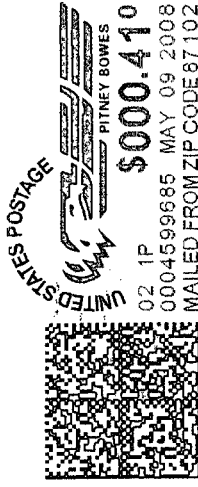

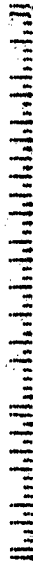

Hi - I just got a call from attorney Robert Gorence of Gorence & Oliveros, P.C. (505) 244-0214, gorence@swcp.com. He will be representing Mack on the brine well case. (He represented them in the GJ West Coop case, too.)

He would like some extra time to respond to the letter, and would like to set up a compliance conference. They can be available this Friday afternoon after about 2 pm, or Monday morning, or March 9 in the afternoon.

If you want them to take any sort of emergency action (for example, shut in the well) you need to let them know. Otherwise he is going to assume that they can continue to operate until this gets resolved.

I was hampered in discussing this with him because there is nothing on the R drive to tell me about this case. No "terms and conditions" form, no copy of the letter, no nothing. I assume I am not handling the case because I have nothing on it.

Would someone please contact him ASAP. He would prefer to hear from counsel; he's uncomfortable dealing with non-counsel directly.
