The New Mexico Oil Conservation Division (OCD) has completed a review of Shell Oil Company's (SOC) January 6, 1995 "DELAWARE STATION, LEA COUNTY, NEW MEXICO". This document contains a final reporting of the remedial actions performed at SOC's Delaware crude pump station and requests final closure of the remedial actions.

SOC's request for final closure is approved. The OCD considers the investigation and remedial actions to be completed in accordance with the regulations in effect at the time of closure.
