The junction was eliminated and the box was removed. The site was remediated using a backhoe while PID and chloride field tests were conducted at regular intervals. Although PID readings were relatively low, the soils exhibited physical signs of slight hydrocarbon impact. Chloride field tests revealed concentrations that did not relent with depth or breadth throughout the 30 x 30 x 12 ft deep excavation. The excavated soil was blended on site and then backfilled into the excavation to 4 ft BGS. At 4 ft, a compacted clay barrier was installed to inhibit further downward migration of remaining chloride impact. The remaining spoils were backfilled on top of the clay and contoured to the surrounding surface. Remaining hydrocarbon is expected to naturally attenuate. An identification plate was placed on the surface of the backfilled site to mark the former location of the junction box and the clay below. NMOCD was notified of potential
