Dear Mr. Allen:

The New Mexico Oil Conservation Division (NMOCD) has received and reviewed the report shown above submitted by you on behalf of Americo Energy (Americo). This report is hereby approved with the following understandings and conditions:

1. Monitor wells at the site will continue to be sampled for chlorides on a quarterly basis.
2. Results of such monitoring will be reported to the NMOCD on a semi-annual basis.
3. Since the monitor wells were last sampled in June and July of 2005, Americo will be responsible for sampling again on or about November 15, 2005 and March 31, 2006. Sample analyses results are to be reported to the NMOCD by April, 30, 2006 and then semi-annually thereafter.
