The New Mexico Oil Conservation Division (OCD) has reviewed EOTT Energy Pipeline Limited Partnership's (EOTT) May 3, 2000 "BOB DURHAM RELEASE SITE, NE ¼ NW ¼ SECTION 32, TOWNSHIP 19 SOUTH, RANGE 37 EAST, LEA COUNTY, EMERGENCY RESPONSE – PHASE SEPARATED HYDROCARBON (PSH) RECOVERY". This document contains EOTT's interim plan for installation of free phase hydrocarbon recovery system in the existing excavation and backfilling of the excavation to reduce site safety hazards at the Bob Durham/Old TNMPL Monument (Vacuum) 10" Pipeline Site.

The above referenced plan is approved with the following conditions:

1. EOTT shall include information on the backfilling of the excavation and as built construction information for the recovery system in the Stage 1 work plan.
2. All wastes generated shall be disposed of at an OCD approved facility.
3. EOTT shall notify the OCD at least 48 hours in advance of the scheduled activities such that the OCD has the opportunity to witness the events.

Please be advised that OCD approval does not relieve EOTT of liability if the system fails to adequately remediate contamination related to EOTT's operations. In addition, OCD approval does not relieve EOTT of responsibility for compliance with any other federal, state or local laws and regulations.
