Gentlemen:

On December 27, 1954, by virtue of the provisions of Administrative Order NSP-60, I approved the formation of a non-standard gas proration unit consisting of the following described acreage in the Jalmat Gas Peel:

Section 10, Township 22 South, Range 36 Fast

Information available to me at this time indicates that I exceeded the authority granted to me by the provisions of Rule 5-b of Order R-520, (Jalmat Pool Rules) due to the fact that the third paragraph of Rule 5-a specifically limits the maximum amount of acreage that may be assigned to a gas well, the amount being governed by the well location.

The formation of a 320-acre non-standard protation unit with your-H. S. Record Lease, Well No. 1, located 990 feet from the South line and 990 feet from the East line is contrary to the provisions of this rule.

On February 16, 1955, this Commission will hold hearings directed to you as operator for you to show cause why the acreage assigned your H. S. Record Well No. 1, SE/4 SE/4, Section 10, Township 22 South, Range 36 East, NMPM, Jalmat Gas Pool, should not be reduced to 160 acres in accordance with the provisions of paragraph 3 of Rule 5-a of Order R-520. THE APPLICATION OF THE COMMISSION UPON ITS OWN MOTION, DIRECTED TO WESTERN NATURAL GAS COMPANY, FOR THE RECONSIDERATION OF ADMINISTRATIVE ORDER NSP-60 WHICH CREATED A 320-ACRE NON-STANDARD GAS PRORATION UNIT IN THE JALMAT GAS POOL CONSISTING OF THE S/2 OF SECTION 10, TOWNSHIP 22 SOUTH, RANGE 36 EAST, NMPM, LEA COUNTY, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 16, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter refered to as the "Commission".

NOW, on this 28th day of February, 1955, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises,

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to provisions of Rule 5 (a) of the Special Rules and Regulations for the Jalmat Gas Pool of Order No. R-520, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal section after notice and hearing by the Commission.

(3) That applicant, Western Natural Gas Company, is the owner of an oil and gas lease in Lea County, New Mexico the land consisting of other than a legal section, and described as follows, to-wit:

TOWNSHIP 22 SOUTH, RANGE 36 EAST, NMPM

S/2 of Section 10

containing 320 acres, more or less.

(4) That applicant, Western Natural Gas Company, has a producing well on the aforesaid lease known as H. S. Record #1, located 990 feet from the south and east lines of Section 10, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico.

(5) That the above-described 320-acre non-standard gas proration unit has been producing under the provisions of administrative order NSP-60, and that Western Natural Gas Company was required to, and did, show cause why this 320acre proration unit should not be reduced in size.

(6) That it is impractical to pool applicant's said lease with adjoining acreage in the Jalmat Gas Pool, and that the owners of adjoining acreage in said area have not objected to the formation of the proposed proration unit of 320-acres.

(7) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be drprived of the opportunity to recover its just and equitable share of the natural gas in the Jalmat Gas Pool.

(8) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste, and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Western Natural Gas Company for approval of an unorthodox proration unit consisting of the following described acreage:

TOWNSHIP 22 SOUTH, RANGE 36 EAST, NM PM S/2 of Section 10

be and the same is hereby approved, and a proration unit consisting of the aforesaid acreage is hereby created.

(2) That applicant's well, H. S. Record Well No. 1, located in the SE/4 SE/4 of Section 10, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, shall be granted an allowable in the proportion that the above described 320-acre unit bears to the standard or othodox proration unit for said pool, all until further order of the Commission.
