Gentlemen:

Reference is made to your application for a non-standard gas provided unit in the James Cas Pool comprising the E/2 of Section 6. Township 19 South, Range 37 East, NMPM, Lea County, New Mexico. This unit is ascribed to your State "C" NGT-6 Well No. 1, located in the NW/4 SE/4 of Section 6.

In Administrative Order NSP-85, we erroneously assigned only 324 acres to your non-standard gas proration unit. Upon checking and inspecting the above described acreage we find that said acreage contains 324.62 acres and should therefore be assigned an allowable based upon a unit size of 325 acres.

Gentlemen:

Reference is made to your application for approval of a 324-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:
