Gentlemen:

Reference is made to your application for a non-standard gas proration unit in the ~~Jalmat~~ ^{Juniper} Gas Pool comprising the E/2 of Section 6, Township 19 South, Range 37 East, NMPM, Lea County, New Mexico. This unit is ascribed to your State "C" NCT-6 Well No. 1, located in the NW/4 SE/4 of Section 6.

In Administrative Order NSP-85, we erroneously assigned only 324 acres to your non-standard gas proration unit. Upon checking and inspecting the above described acreage we find that said acreage contains 324.62 acres and should therefore be assigned an allowable based upon a unit size of 325 acres.

By authority granted me under provisions of Rule 5, Section (b)-5 of the Special Rules and Regulations of the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto based upon the unit size of 325 acres.

Reference is made to your application for approval of a 324-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

It is understood that this unit is to be ascribed to your State "C" NCT-6 Well No. 1, located in the NW/4 SE/4 of Section 6, Township 19 South, Range 37 East, NMPM, Lea County, New Mexico.

Inasmuch as we are in receipt of waivers from the offset operators agreeing to the formation of the proposed unit, it is possible for immediate approval to be granted. Therefore, by authority granted me under provisions of Rule 5, Section (b)-5 of the Special Rules and Regulations of the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 324 acres.
