Gentlemen:

Chevron U.S.A. Inc. respectfully requests administrative approval to amend Order NSP-152 by reducing the 320-acre non-standard Eumont Gas Proration Unit to a 280-acre non-standard gas proration unit. The reason for the reduction is due to recently completing the H. T. Mattern (NCT-A) Well No. 5 as a Eumont Oil well. This well is located 660' FSL and 990' FWL of Unit M, Section 24, T-21-S, R-36-E, Lea County, New Mexico. At this time we are also requesting to simultaneously dedicate the H. T. Mattern (NCT-A) Well No. 2 along with the H. T. Matten (NCT-A) Well No. 1 to the above listed 280acre non-standard gas proration unit. The 280-acre proration unit will be formed by deleting the SW/4 SW/4 of said Section 24 from the current proration unit. In support thereof, Chevron U.S.A. Inc. states the following facts:

 Order NSP-152 dated June 15, 1955, approved a 320-acre non-standard gas proration unit in the Eumont Gas Pool comprising the S/2 of Section 24, all in T-21-S, R-36-E, NMPM, Lea County, New Mexico.

2) That Chevrons' H. T. Mattern (NCT-A) Well No. 5 located

in Unit M of Section 24, T-21-S, R-36-E, has recently been completed as a Eumont oil well. This reduces the non-standard proration unit for Well No. 1 to 280-acres.

3) That Chevrons' H. T. Mattern (NCT-A) Well No. 2 located in Unit J of Section 24, T-21-S, R-36-E, has recently been approved by District N.M.O.C.D. for recompletion into the Eumont gas zone, and we wish to simultaneously dedicate this well with the H.T. Mattern (NCT-A) Well No. 1.

Attached is a plat outlining the proposed non-standard Gas Proration Unit, and a map showing all offset properties and wells.






