Cause of Release Produced water trunk line going to tanks developed a small leak. All fluid stayed on location. Contaminated soil: 12'x60'x1" = 59.76ft³ = 10.65 bbls x 10% Clay = 1.06 bbls. Standing Fluid Calculation: 11'x58'x1" = 52.954ft³ = 9.42 bbls. Contaminated soil + standing fluid = 10.48 bbls. Calculation completed at the time of discovery.
