
#### Cause of Release

A water hauler had pulled a load of water from the water tank and when he completed the job he forgot to disconnect his hose from the load line. When he drove off the load line pulled apart and the containment wall was damaged. The truck driver came back and recovered the 20 barrels of produced water from the lined containment. The trucking company had the line fixed, containment wall was repaired and containment cleaned. The cause of the spill was due to human error, 20 barrels of produced water were released and 20 barrels of produced water were recovered.
