Mr. Settle,

The OCD has denied the submitted Remediation Plan C-141 for incident # NCS2002754182 for the following reasons:

- The Depth to groundwater has been incorrectly assessed. When nearby wells are used to determine depth to groundwater, the wells should be no further than ½ mile away from the site, and data should be no more than 25 years old, and well construction information should be provided. If EOG believes that groundwater is > 100', a borehole will need to be drilled onsite and a copy of the driller's log must be provided.
- If EOG chooses not to drill a borehole to confirm the depth to groundwater, the site must be remediated to meet the Closure Criteria in Table 1 for groundwater at a depth of 50 feet or less.
