XTO is requesting an extension to the 90-day timeline for completed remediation and closure report submittal required in 19.15.29.12.B.(1) NMAC at the PLU #420 Battery (RP# 2RP-5102). The release occurred on November 19, 2018. XTO began site characterization sampling on November 27, 2018 and proceeded with excavation of impacted soil based on soil sampling results. Excavation confirmation sampling data from the most recent samples (collected February 6, 2019 indicate additional soil removal and sampling is necessary. XTO estimates final work and reporting can be

completed within two weeks. The 90-day deadline from the release date is February 17, 2019. XTO requests an extension of this deadline until February 28, 2019.
