The spill rule requires the spill be fully delineated horizontally and vertically. The entire perimeter of the excavation looks hot with contamination. Could you please take additional samples moving out from the perimeter of the excavation so that we have a better idea of the actual size of the spill. Also, please delineate vertically (1, 2, 3 ft intervals) as far as you can go before hitting bedrock. An updated site map and soil analytics results page would be very helpful in making a final decision on a possible deferral.
