All,

XTO is requesting an extension to the current deadline of December 30, 2019 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Nash Unit 302H-402H (RP Not Assigned). The release was discovered on October 1, 2019 and initial site assessment began October 15, 2019. However, ongoing frac operations near the release delayed further delineation and excavation of impacted soils due to site restrictions for safety concerns. This has prevented XTO from completing remediation work. Regular updates of the operational will continue to be provided to ensure that work begins as soon as the production operations are complete. To provide enough time to fully assess the site and conduct remediation work, XTO requests an extension of the deadline until May 29, 2020.
