All,

XTO is requesting a second extension of the current deadline of September 30, 2019 for completing a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Palmillo State #001H (2RP-5389). The release was discovered April 1, 2019. XTO initiated site characterization the same day. The release occurred in the pasture along the Palmillo flowline on State land. A Right of Entry (ROE) Permit was submitted to the State Land Office (SLO) on May 24, 2019. The executed permit was received from the SLO on August 14, 2019. SLO has requested XTO to have an archeologist monitor onsite during any remediation work within the pasture. XTO has contracted an archeological survey company to complete this work. Remedial action will commence as soon as an archeological monitor is available, which is tentatively scheduled for mid-November 2019. To provide enough time for further site assessment of the pasture, remediation work, and the completion of a remediation work plan or closure report, XTO requests an extension of the deadline to February 28, 2020.
