We had a State Land Office individual in that area in late January doing some ROW assignments and she noticed some issues (holes) in the liner down by the short tank and took some pictures. Understandably, this is on the opposite end of the tank battery where this particular spill took place. Be advised that under the current spill rule (19.15.29 NMAC) effective August 14, 2018, certification on form C-141 that the responsible party has visually inspected the liner where the release occurred and the liner remains intact and had the ability to contain the leak in question. Could you please send any pictures taken during the liner inspection and insure certification on form C-141 that the liner was visually inspected.
