XTO is requesting an extension for the current deadline of December 29, 2020 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Muy Wayno Frac Pond (Incident Number NRM2028948451). The release was discovered on September 30, 2020 and initial site assessment was conducted. Remediation activities are currently ongoing, and the most recent laboratory analytical results indicate further remediation work is warranted. In order to complete the remediation work and submit a remediation work plan or closure report XTO requests a 30-day extension of this deadline until January 29, 2021.
